- 4. The bids will be opened in the presence of bidders'representatives who choose to attend at 13:00 hours on 2074/12/02 at the office of Dhanpalthan Rural Municipality Sorabhag, Morang. Bids must be valid for aperiod of 90days after bid opening and must be accompanied by a bid security, which shall be valid for at least 30days beyond the validity period of the bid;i.e.minimum120days after the date of bid opening.
- 5. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
